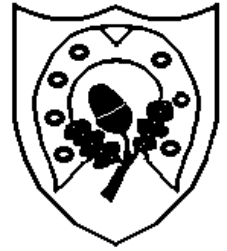

## **GENERAL INFORMATION**

1. All archers must be affiliated to GNAS or a FITA Member Association & they will be asked to produce their membership cards when signing in.
2. Awards will be made to all classes, subject to entry.
3. Two practice ends will be shot at the start of each Combined FITA round.
4. FITA triple vertical faces will be used.
5. GNAS dress regulations as shown in GNAS Rule 307 will apply. Archers must wear plain dark green / white or officially registered alternative shooting colours. Soft soled shoes must be worn.
6. Record Status shoots will be liable for drug testing, and competitors approached to give samples must comply; refusal will be treated as a positive result. Juniors' entry forms must be signed by a parent or guardian to signify their consent to their child being tested if approached.
7. Light refreshments will be available.
8. Smoking and drinks are prohibited in the main hall.
9. The organisers cannot accept responsibility for loss or damage to equipment or personal possessions.
10. Target and Results lists will be sent in .PDF format to those including an e-mail address. If absolutely necessary, hard copies will be sent if stamped, self-addressed envelopes (23cm x 16cm minimum) are included.
